Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, Rehmat Traders Limited is authorised to sell alcohol on the premises situated at 46 Main Street Oxford and known as Super Liquor Oxford, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- (b) Alcohol may only be sold or supplied on the following days and during the following hours when the premises are being operated as a **Retail Bottle Store**:

Monday to Sunday 10.00am to 10.00pm

- (c) Water must be freely available to customers on the premises during tastings.
- (d) The premises is designated as a supervised area.
- (e) Alcohol must only be and displayed within the area marked on the plan submitted with the application.
- (f) The premises are more precisely identified as outlined in a plan date stamper received by the Waimakariri Dis *Licensing Committee on 18 September 2019.
- (g) A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the Main Street, Oxford is designated as the principal entrance.
- (h) The licensee must implement and maintain the steps proposed in their Host Responsibity Policy aimed at promoting the reasonable sale and supply of alcohol..
- (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
